PRESIDENT'S ROAD REPORT.....Charlie Waterman

The two biggest accomplishments for our Association last fall were the replacement of the Garcock bridge with two culverts and the tree clearing on the section of Sebec Shores Road between the road to Big Bennett down to the "Y".

The demise of the Garcock bridge is somewhat of a landmark for the Association in that it was the last of the old wooden bridges in our road system to get replaced with culverts. Over the years we seem to have tried all kinds of approaches to bridge building, but the bottom line has always been that wooden bridges don't last very long. Added to that, it was always a major project to assemble enough bodies at the same time to rebuild them. We had considered a bridge with steel grating in lieu of wooden decking before going the culvert route, which probably would have provided a life span equivalent to the culverts, but we were unable to come up with a reasonable source of supply for grating. Mac Drummond did a great job of installing the culverts in less than one day, which minimized problems for the few folks still in camp who were downstream from the project. He also got rid of the steel from the old bridge which supported the old wooden decking.

As for the tree clearing. You probably all know the problems with that section of Sebec Shores Road between the road to Big Bennett and the "Y". The sun never got to it, and as a result it never dried out. No matter what we did to the road, the potholes quickly came back, became bigger and totally unavoidable. We, as property owners, have an easement through this area for the maintenance of the road (16.5 feet either side of centerline). Last fall we contracted with Arrow Tree Service to clear to the limits of our easement to, as they put it, "to the sky". They also chipped and removed all slash. I'm sure you'll all see a big difference when you come in this year. Obviously this isn't the end of the work in this area as we will have to see what we can do to improve drainage, etc. There is a lot of ledge in this particular area which complicates things but at least we have started. As you recall, the clearing and ditching on the big hill took several years to get it to where it is now.

In other Board activity, John Lowe is going to get the water from the spring tested first thing this year. I guess there are quite a few people who are using the spring; thus the decision to test it.

There are several issues regarding the State's budget currently under review in the legislature which might impact us, but best we leave these until our July meeting when perhaps things may be a bit more definitive.



Take a Hike - Dot Blanchard

Are you looking for a new hike? --- something not too far away nor too difficult, but with excellent views and a little challenge at the top? Eagle Rock, just north of Greenville is the perfect solution. I learned about this trail in Christopher Keene's North Woods Walks. He confesses that he didn't know it existed until his father discovered it while hunting. Eagle Rock is actually the northwest shoulder of Big Squaw mountain, and it rises up out of the forest as a great bald ledge with some outstanding North Country views. To get to the trailhead, however, you need to follow specific directions. From the railroad trestle in Greenville Jct. drive 7 miles toward Rockwood on Rt. 15. Turn left on Burnham Rd., a gravel road with its share of potholes (but OK for cars). Begin new mileage here. Drive 3.7 miles to an intersection, take a left, and at 4.9 miles the trail begins on the left side of the road. There is no sign, but the 2-mile trail is in the woods between two clearcut areas. Look carefully and you will see a well-worn path. There is limited parking off the road at the beginning of the second clearcut. The trail starts out on level ground, then joins an old road. At 0.2 mi, the trail leaves the road and bears right uphill. Although there are no blazes, the trail is occasionally marked with orange tape and the footpath is easy to follow. It rises through open woods via switchbacks to a couple of level places, then through spruces and cedars until it climbs steadily to the height of land. At this point look to your right where the smooth ledge rises steeply above the trees. Be careful, especially if the surface is wet. (I would suggest waiting for a dry, sunny day.) The views are panoramic, from Katahdin on the east to Bigelow on the west to Boundary Bald and Quebec on the north. The ledge itself is fascinating. Rock climbers and rescue groups have used the steep western face, as evidenced by the pitons and chains driven into the rock. It's a great place for a picnic and for taking photos. You will be surprised by the views and the rock formations. Take some time to explore this interesting 2367-ft. summit-----but keep track of the kids!

For Your Information

The Shoreland Zoning Act is a State law that regulates many activities within 250 feet of lakes, and wetlands and within 75 feet of streams. The Town of Willimantic also has a Building Code. It seems as though lately there have been quite a few instances where property owners have gotten cross-wise with one or both of these regulations, in at least one case with very severe consequences. Turnpike Widening is finished.....Yea! However if your providing driving instructions to someone unfamiliar with the area, they did change all the exit numbers on I-95, based on mileage from Kittery. They also designated the full length of the Turnpike as I-95. It used to shift over to the easterly highway north of Portland on up to Augusta.

Tim's Cove Road Commissioner, Greg Kemp, is looking at ditching, fixing pothole areas, getting as much good gravel down as possible, and grading as goals for the Tim's Cove Rd. for 2005. Specific areas of attention will be an area of the road by the Hilton camp, fill at Salmon Stream, pulling old culverts and culvert replacement where needed. Work will be done as funds allow.

Annual Meeting - This year the 4th of July falls on a Monday. This probably means that quite a few of our members and/or their guests will be either preparing to head home or else they will be trying to finish their "to do" lists, which always takes longer to accomplish than the time originally anticipated (especially the fun things on the list). 
