

TCPOA 1994 SUMMARY By Gene Snyder, President

During 1994 TCPOA spent over \$5,000. on improving the Tim's Cove Rd., South Cove Rd. and The Sebec Shores Rd. At the Memorial Day Director's meeting the two road directors, Paul Belmain and Hoyt Fairbrother, were authorized to spend \$2,000. on both the South Cove Rd. and the Tim's Cove Rd. This work was accomplished before the July 4th meeting. Wayne Smith was paid for work accomplished in 1993 and 1994 on the Sebec Shore Rd. in accordance with the motion passed at the 1993 annual meeting. Plans were also made to do more work on the Sebec Shore Rd., depending on the available funds. A damaged culvert was replaced by Mac Drummond at the top of the hill in July. However, the badly deteriorated condition of the bridge on South Cove Rd. made its replacement mandatory for safe travel. Therefore, work on Sebec Shore Rd. was postponed until the bridge could be replaced and we saw how much money was left in the treasury.

At another director's meeting, Hoyt Fairbrother pointed out the bridge on Tim's Cove Rd. would also need to be replaced in another year. To hold expenses for the two bridges to a minimum, the Director's elected to take down 10 large trees on the two lots the Association owns and use them for bridge timbers. In July and August those trees were taken down, cut into logs and sawn into bridge timbers. The tree cutting was done by

tree expert, Jack Sincyr, and Central Maine Power, with the assistance of several South Cove Rd. residents. Roland Church, Bob Meade, and their mobile sawmill were hired to saw the logs into timbers, again with the help of some So. Cove Rd. friends. September 10th saw the tearing apart and reconstruction of the bridge in one day!

MORE NOTES FROM THE PRESIDENT

Also in September the remaining logs were sawn and the timbers secured for the Tim's Cove Rd. bridge. The 10 trees, which ranged upwards of 26 inches in diameter at the base, produced over 5500 board feet of timber and saved the Association thousands of dollars.

Special thanks to Steve Smith for providing a man and log loader to tear up the old bridge and dispose of it. Also thanks to Webber Hardware for their discount on the bridge hardware. And finally, thanks to the guys who showed up to work the logs and build the bridge.

After the bills were paid for the sawing and handling of the bridge timber the treasurer reported there was sufficient money remaining to permit \$1400, worth of work on the Sebec Shores Rd. while still carrying \$1,000. through the winter for emergency road work in the spring. However, even though the work was scheduled to ditch areas in dire need and fix the large water hole near the top of the hill, winter set in before the work could be accomplished. That work will be carried over at the top of the Sebec Shore Rd. priority list. providing everything else comes through the winter o.k.

LAKE LEVEL

Residents who remained through October saw the summer lake level maintained until October 15th. Traditionally the lake level is dropped several feet from 322.8 ft. summer elevation, starting the week after Labor Day. However, this past year, the State Dept. of Inland Fisheries and Wildlife worked out a compromise with sporting camp owners, Sebec Lake Association. Bangor-Hydro and the Swift River Power Company, to keep this level high through most of the fall salmon run. This was to help improve the salmon spawning and increase the number of wild salmon in the lake. Gene Snyder attended a meeting in Bangor in September where this compromise was worked out in conjunction with the construction of a fish ladder to further enhance the salmon run. The maintained water level through September means docks can remain in later to enjoy the fall fishing and boating. To preclude the danger of flooding during this period, the Swift River Power Co. was given pemission to

lower the water level earlier if they saw a major storm approaching. When they did lower the water level they were able to drop it over 3 feet in a week. Although the late draw down was a temporary measure in 1994, it probably will be retained in some form to keep improving the salmon population since this is how the state has decided to manage the lake. If anyone has any thoughts on this subject, please drop me a line.

NOTICES

BUTTERFLIES and MOTHS

The transformation from caterpillar to butterfly never fails to delight a child (or us). To observe this magical metamorphosis, find a catepillar and place it in a cage where there is plenty of air circulating. Be sure to include some of the leaves it was eating when found, and supply fresh ones daily. Because the caterpillar could turn into either a butterfly or a moth, prepare for both: Put an inch of potting soil in the bottom of the cage (some moths make their change underground), and lean a few sticks against the inside of the cage for a butterlfly larva to hang from when it's changing. Your child can count how many times the caterpillar sheds its skin, and then watch for it to form a cocoon. When the coccon opens, what have you got? Try to release the moth or butterfly in the area where the catepillar was found. Caterpillars are most often found during late spring and early summer.

Look up the different stages that the caterpillar goes through in its transformation to a butterfly for better understanding.

We sleep, listening on summer porches; lamenting mournful loon songs reaching our souls.




We sit softly on sandy shores; shrouded misty mountains reflected touching bottom.

We ready for raging storms, crackling fire secured, dreaming summer dreams.
















